Board of Director's Meeting 3 June 2014

The meeting was called to order at 7:44 PM.

Mike Sullivan made a motion that the Agenda be approved with minor changes.

In attendance were: Tracey Combs, Corrine Mulberry, John Geddes, Doug Geddes, Dan Miller, and Mike Sullivan.

Dan handed-out Treasurer's Report for May, Treasurer's Report for the Cayman trip, May transactions details and funds on account, and Funds on Account for Year Report.

Tracey asked that an email be sent Thursday about a Social being held prior to the June General Meeting instead of a program and that the individual cost of \$6 be paid to participate.



Corrine showed a certificate that is presented to the Club for the Adoption of a Coral Reef in Florida. She indicated that 2 new members have joined this past month; Susan Edgington and Barbara Wentz. The program for July will be a video on Indonesia. John indicated that the Newsletter will be emailed on Thursday.

Corrine indicated that the reservation deadline is June 15th for the Dale Hollow trip. Doug indicated that the Cayman Island trip is full and the final payment is due June 23rd.



A discussion was held about the Costa Rica trip being planned for June 1015. Doug made a motion that the Volcano Lodge be the selection for the Arenal Volcano portion of the trip. Changes in the sign-up date, 1st payment due date, and final payment date were made as presented by Corrine.

Doug gave a presentation on Dominica for January 2015. He has received a quote from Castle Comfort that includes breakfast for \$1260. After a discussion on the Fort Henry Hotel, Mike made a motion that the Fort Henry Hotel be looked at as an alternate for the trip.

Doug gave a presentation on the Philippines trip planned for January 2016. If we accept the locations, we can lock-in the 2014 rates for the trip. These are \$1409 for Kasai and \$1010 for El Galleon. We would receive 3 comp rooms for 15 paid at Kasai, and 1 comp for 9 paid at El Galleon. John made a motion that we accept these proposed comps and rates.

Corrine indicated that the Membership Forms online do not work properly and need to be updated. There are also differences in the forms and changes need to be made to make them in agreement.

Dan indicated that corrections have been made and the 2013 taxes have been filed.

- Standard Room Diver \$1,243.00/Non-diver \$988.00 (double occupancy)
- Includes group transfers from Liberia Airport to Volcano Lodge; Volcano Lodge to Villas Sol (with lunch) and Villas Sol to Liberia Airport
- 2 night accommodations with 2 breakfasts at Volcano Lodge in the Arneal Volcano area
- 5 night accommodations at Villa Sol all inclusive with breakfast, lunch, dinner, snacks, alcoholic and nonalcoholic drinks.
- Three 2-tank boat dives

Safety Corner

Note: Almost every trip brings new knowledge to the intrepid members of the BGDC. Sometimes it is in seeing a new location or a new type of sealife, other times maybe learning about different cultures, or sometimes even learning to not do something, such as getting fire coral in your bootie.

Now, I'm not naming names, but the name rhymes with Bob Bibbetts... Anyway, it happens to us all. I learned a long time ago to not pet the bristle worms, even with gloves. Other folks have learned not to snorkel their first day out without sun protection. Hey, remember, I said we were learning!

In that spirit, here is an article from watersports.answers.com about fire coral. You might learn a few things about it - I did. And note that peeing on fire coral stings does not work – use vinegar. And don't rinse with fresh water, it will make the nematocysts fire again, injecting more venom.

Best idea – stay away from all coral, that way you preserve the reefs (and your skin).



Remember, safe diving is fun!

Fire Coral: Appearance, Danger, and Treatment

Fire coral is one of the many dangers aspiring scuba divers need to be aware of. The name of this creature is misleading, as it is not actually a coral at all. It is more closely related

to the jellyfish. However, it is often mistaken for coral or sometimes seaweed. You may think you are coming into contact with a harmless creature and be confused when you start experiencing pain and swelling from its sting. Read on to learn more about fire coral, the damage it can inflict, and how to treat it.

What is Fire Coral?

Fire coral is not actually a coral, but a hydrozoan or hydroid, a species related to coral. It has two life forms, a polyp and a medusa, the first of which is immobile and the latter of which is free swimming. Fire coral is most closely related to jellyfish, and like the jellyfish, it can sting. Fire Coral lives in warm, shallow reef areas exposed to sunlight. It can live on the edge of reefs, on the reef face, or on the top of steep drop-offs. It can be found in the warm areas of all oceans and is most common in tropical environments.



What Does Fire Coral Look Like?

Fire coral gets its name because it often resembles coral reefs. It is brown or yellowish-

green in color. Its appearance varies based on the strength of the current in its location. If the current isn't strong, its branches will be thin and will form a lattice that can be mistaken for seaweed. In an area with a stronger current, the fire coral will form thick branches or columns. In very heavy current, it will form a thin encrusting layer. The branches themselves are hollow and brittle.



What are the Dangers of Fire Coral?

Fire corals have tiny, nearly microscopic polyps. The polyps are embedded in the skeleton and are linked by tiny canals. Some of these canals are housed on the surface of the coral, and some of these contain polyps that have nematocysts, or stinging barbs. If you accidentally come into contact with fire coral, it can shoot these barbs and sting you. You will know you have been stung five to thirty minutes after contact. The first symptom will be a burning or stinging sensation. You will develop a red, itchy rash in the affected area with raised bumps or vesicles. Over time, you may experience swelling of the lymph glands, and in extreme cases, vomiting or nausea.

NOTE: In rare cases, a person may have an allergic reaction to a fire coral sting. In this case, it can be very dangerous. If a person starts experiencing shortness of breath, swelling of the face, throat, or tongue, or other symptoms of an allergic reaction after a fire coral sting, seek medical help immediately.

How do You Treat Fire Coral Injuries?

Fortunately, fire coral stings are highly treatable, and as long as the person stung is not allergic, they are not dangerous. If you get stung by a fire coral, rinse the area with saltwater. Avoid fresh water, as it will increase the pain. Treat the area with vinegar to deactivate the venom in the stings. Use a gloved hand or tweezers to carefully remove the barbs, and keep the affected area as immobilized as possible to decrease the chances of spreading the venom. For followup care, you should apply hydrocortisone cream two to three times a day. This will help with itching and prevent infection. Over-thecounter painkillers, such as acetaminophen and ibuprofen, may be used to relieve pain. If the sting develops pus or blisters, seek medical help.

Fire coral stings aren't especially dangerous, but the danger of the fire coral lies in its misleading appearance. Without being familiar with the creature, most would assume it is harmless. A fire coral sting is painful and may take a few days to clear up completely, which can put a damper on any ocean exploration. The best solution is to be aware of the creature and try to avoid contact. If you do experience a fire coral sting, follow these steps to treat the wound as calmly and quickly as possible. The best defense against the dangerous creatures of the ocean is knowledge and preparation.




