Tech Corner: Windows 10 EOL (End of Life) and You

If you are a Microsoft Windows computer owner with Windows 10 as the operating system, then most likely you have received numerous notifications of one sort or the other regarding the End Of Life of Windows 10 and the need to upgrade to the next greatest thing

Windows 11. With this short article I will try to demystify what this all means to you.

Here is a direct quote from Microsoft: "After October 14, 2025, Microsoft will no longer provide free software updates from Windows Update, technical assistance, or security fixes for Windows 10. You PC will still work, but we recommend moving to Windows 11. Windows 11 offers a modern and efficient experience designed to meet current demands for heightened security."

Some truths and myths surrounding this topic:

1. Some newer PC's may be able to upgrade to Windows 11. Some older PC's will not support running Windows 11. You can find out using this weblink End of support for Windows 10, Windows 8.1, and Windows 7 | Microsoft Windows

2. Your PC will still work. If you continue to use Windows 10 it would be most important to have installed and active 3rd party antivirus and antimalware protection program with real time detection and scheduled scans. This security protection will be continuing to try and keep your PC with Windows 10 safe from attack.

I personally find that the Dive Assure annual travel insurance, for both travel and dive accident protection, is a better value for us. It used to be than the DAN annual travel and dive accident insurance was the better value.

I Got a Taste of Diving Safety from This SAFETY BITE

My mission is to provide you relevant safety information for your use. Each article will be a bite size portion of a specific safety risk. I will draw from my experience, hopefully yours, and the dive community to highlight real risks that we must be aware of. So, if you see or hear of something that we could all learn from, please pass it to me. There is nothing like first-hand experience to drive a point home. This month's **SAFETY BITE** is:

DIVER'S UNDERWATER SCISSORS

Note from Bart: For the first 20 years or so of my diving I carried a knife. I started with a big knife strapped to my leg. That tended to snag the California kelp so I went with a smaller

knife on my weight belt. That eventually became a smaller and smaller knife that ended in my BC pocket out of the way. California shore and rock breakwater diving was relatively shallow and meant the possibility of encountering fishing line and gear, especially in a strong current.

Entanglement was something that you had to deal with once in a while. And it could just as easily be your buddy who needs your help. When I did have to use my knife, it was never easy. For one thing, it took two hands and if you have something in one hand like your light; it could be a real pain. Then a fellow diver showed me what scissors could do and wow, what a difference. I've never dove with a knife since.



Diving scissors, also commonly referred to as dive shears or diving shears, are a great addition to any avid scuba divers gear kit. Crafted specifically for underwater use, these robust shears are designed to offer versatility and reliability beneath the waves. Unlike regular scissors, dive scissors are engineered to cut through tough materials like fishing lines, nets, kelp, and even thin ropes, which can become a hazard during dives. Their stainless-steel construction ensures resistance to rust and corrosion, key features given the salty sea environment in which they operate. The ergonomic design of these tools allows for easy handling, even when wearing thick diving gloves, making them an

indispensable companion for both safety and convenience in any underwater environment.

They also work well topside and come in handy when you have to cut anything.

Having a good pair of underwater scissors can make all the difference. There are many accounts of turtles or dolphins entangled in fishing line that were saved by divers. Just a few snips from the diving scissors is all it takes. But it's not just about functionality; it's about being prepared to handle unexpected challenges that may arise while exploring the underwater world. These tools are not only practical but also add much to a diver's readiness and safety.

As diving often involves encountering situations where entanglement could occur, such as exploring shipwrecks, shore diving near popular fishing spots, night diving, or navigating through dense underwater forests of seaweed, having a pair of dive scissors handy could literally be a lifesaver. Consider investing in a pair of quality diving scissors that will enhance your diving experience and your safety by ensuring peace of mind and preparedness when under the sea.
